MAJOR CONTRIBUTIONS

- Each job in professional services HQs contributes \$147,749 to gross product for the Tulsa 11-county area.
- Ten jobs in professional services HQs support 5.8 jobs in resource-supplying companies.
- Throughout the Tulsa-area economy, 10 jobs in professional services HQs support 13.5 additional jobs across all sectors.
- Each dollar of income by an employee in professional services HQs supports the earning of an additional \$0.84 throughout the Tulsa-area economy.
- Each dollar of production (value added) in Tulsa-area professional services HQs supports an additional \$0.68 of gross product throughout the economy.
- One year's activity in Tulsa-area professional services HQs supports total sales tax of \$100.4 million and total property tax of \$114.8 million.
